

# Counting the cost of outside influences **Matthew Airey** Chair **G TOGETHER** DR HIGH UALITY CARE

I'm starting this year's Wiltshire Care Partnership Annual Review with some data that gave me a great sense of pride when it was published by the Care Quality Commission just a few weeks ago:

- 83% of adult social care services were rated as good or outstanding
- 96% of GP practices were rated as good or outstanding
- 75% of NHS acute core services were rated as good or outstanding
- 77% of all mental health core services (NHS and independent) were rated as good or outstanding.

Within the State of Care Report for 2022, which these numbers are taken from, CQC has outlined in detail how health and social care services are gridlocked, and that public satisfaction with services, particularly health, has fallen since last year's report was published. I haven't included this data to boast about how well adult care services are doing compared to NHS acute and mental health services, but to congratulate our army of dedicated care workers who, despite all the challenges facing them this year, are continuing to perform to a very high standard, giving care and support to an ever growing number of people who rely on care staff for their daily needs. There's no two ways about it, the adult care sector is groaning under the weight of decades of under investment, and yet the standard of care that you give is overwhelmingly good.

This year has had a real feel of 'just when we thought it couldn't get any worse'. Coming out of the pandemic and still dealing with impact on staffing caused by Brexit, the last thing anyone needed were the tragic scenes in February this year as Russia invaded Ukraine. Alongside the human cost on the ground, around the world it triggered sharp rises in goods and fuel costs, high inflation and the threat of shortages and more price hikes to come. For care providers, the knock-on effects have been huge and, with government seeming to roll back on social care reform and the cost of care exercise, we no doubt face huge challenges in the year ahead.



# Our tenth year supporting care providers

### At WCP we have continued to support providers both collectively and individually in a number of ways.

In August this year we were joined by a third Trusted Assessor, Poppy Noke, who comes to us with a background in home care and all the knowledge and expertise of what those providers require to make needs-based decisions. We are now offering a free, fast and detailed assessment service to all types of provider from any acute, community or home setting. If you need to assess someone coming in (or returning to) your service, our Trusted Assessor team can offer you a service. With a third team member, our resilience and coverage is better than ever.

We've also been joined by Paul De La Haye, who has come on board to project manage support to care providers who want to implement a digital care records system, and benefit from a three year government pot to offer up to 50% match funding to help share the cost.

Both of these work streams provide direct support to providers and will help free up time and money over the coming years.

On the WCP board, we said goodbye to Pete Bates this year, and welcomed David Towells in his stead, representing the LD & Supported Living part of the sector, ensuring our board retains knowledge and expertise across the breadth of services.

#### **Our achievements in 2022**

Our tenth full year as a not-for-profit organisation supporting and representing care providers has been a busy year, with lots of outside influences impacting the care sector. In our work to represent the care sector this year we have:

We joined the Integrated Care System at Wiltshire Locality level, representing the sector on the Partnership and Delivery Boards. It is early days for this latest NHS structure and we have successfully lobbied for our place at the table.

There are ongoing discussions about tenders for home care, and short term assessment and therapy beds in Wiltshire, with WCP chairing the Pathway 2 (Discharge to Assess/Therapy beds) project group that developed the commissioning strategy earlier in the year. There is work underway to develop a clearer commissioning strategy for End of Life Care, which WCP is part of, and there are changes to Funded Nursing Care payments that we have commented on and will continue to monitor. It's very clear that significant challenges face both the Local Authority and the NHS in terms of affordability in the coming years, and WCP is committed to ensuring the pressures felt by care providers are taken fully into account as part of the process.

We've also tried to talk about topics other than Covid-19 and costs, hosting webinars on fire safety, CQC's new inspection regime and the new ReSPECT form process. We plan to run monthly webinars on themed topics throughout the next year and we're delighted we've attracted so many different faces to our online events this autumn.

As mentioned, we've got a new digital string to our bow with our work on digital care records, which sits nicely alongside our support offer to complete the Data Security & Protection Toolkit that we'll continue to provide until at least the end of March 2023.

#### Other major achievements include...

The Net to Gross payment project has finally started to roll out, with the first providers going 'live' in October 2022. We campaigned for this Care Act duty to be implemented by Wiltshire Council for years, so it's wonderful to see it finally happening after a long project working with the council.

Our other big project this year has been on recruitment and retention, with Wiltshire Council providing funding for us to run a county wide recruitment campaign that will last 18 months, from July 2022 to December 2023. There are now radio ads, social media campaigns, print media ads, articles and billboards, all featuring recognisable and distinctive branding, with stories from real people working in care in Wiltshire. All the material can also be found on our website, and we've recently added a job board that is free for providers to use and will be retained for use after the lifetime of the current campaign. Our aim is to create a brand, an impetus and a buzz around working in care in Wiltshire, using our best asset – care staff – to create that narrative.





During 2023 we are working hard with providers and partners at the Council and NHS to really look at what care is needed, what it costs and how to pay for it, and how to make sure the right services are being commissioned.

We'll continue our focus on recruitment and retention, with our jobs site and campaign running until December 2023, and other options like our menopause awareness resources to support people to stay in their roles.

We'll also be looking at a range of ways to help providers, including our long-running and successful digital projects that encourage safe, secure and supported adoption of digital systems to help deliver care. We expect this to extend to cover sensor based falls monitoring this year and we'll be bringing updates about this in due course.

We are continuing with our monthly themed webinars, our newsletters and information sharing and our one-to-one support for you all and developing our popular Trusted Assessor service.

Thank you to all our members and partners for helping us to learn and grow so we can offer you the best support possible.
